MEMORANDUM OF UNDERSTANDING

At a meeting held on Tuesday 30th July, 2024 between Nargis Kasmani, representing Medical and Educational Aid to Kenya (MEAK), and The Hon Jaldesa Guyo Waqo, M. P, representing Moyale Constituency. It was decided that an eye mission to Moyale constituency will be arranged by MEAK to run from 1st September – 10th September 2024 for the purpose of examining, diagnosing and operating on patients with cloudy cataract lens and other minor visual impairments in an effort to improve their eyesight. There will also be a dental team treating patients all without charge.

It was agreed that each party to the agreement should contribute the following aspects of the

mission

MEDICAL & EDUCATIONAL AID TO KENYA

- Pay the allowances of a medical team of approximately 15 personnel, recruited mainly from Lions Sight First Hospital
- Pay for the transportation of the team, by road, to Sololo.
- · Provide two operating microscopes and surgical sets
- Provide inter ocular lens for approx. 300 patients
- Provide necessary surgical consumables and medicines for approx. 300 procedures
- Provide eye drops and vitamin drops for approx. 2000 patients.
- Provide reading and sun glasses for approx. 500 patients including small number with special photo chromatic lenses
 - Provide medication etc. for dental patients.
- · Share all data collected with collaborating hospital and ophthalmologist
- · Leave medicines to be distributed at the post op. reviews.
